Abstract

Removes the persistent central scattered light feature from the OM images.

3 Description




Figure 1: An example of the XMM OM image containing the central scattered light feature (Obs. ID 0112250301, exposure 006, filter V).

XMM Newton Optical Monitor images are contaminated by a persistent scattered light feature (Fig.1). This feature is a consequence of a uniform background outside of the telescope field of view scattered off of shiny telescope structure. It therefore scales with the background and can be removed in principle. The task *omscattered* performs this function.




Figure 2: Central part of the image containing the calibrated scattered light feature for the OM V-filter.

In order to remove the central scattered light feature a calibrated image containing exclusively this feature is required (the name of the file with this feature can be indicated by the parameter scatset). An example of the image with the calibrated scattered light (for the OM V-filter) is given in Fig.2.

Calibrated images, one for each filter, containing the scattered structure are planned for inclusion in the SAS CAL system. However, for SAS v9.0 these calibration images can be obtained by direct download from the following URL:

The task *omscattered* can be called with the following parameters:

(the first two parameters are mandatory).

If the second parameter (scatset) is omitted (the file containing the calibrated scattered light feature is not specified) then omscattered will first try to find the appropriate calibration file among the files of the SAS system itself, and only in the case of not finding the required file the task will issue an error message and finish without producing any output file.

If the name of the output file (third parameter) is not specified, the task will use the name of the input file but with an extra letter "S" at the beginning of the name.

Otherwise, a default value (currently set to 280 unbinned pixels) is used for the inner radius of this ring-shaped region.

the scaling factor for the calibrated scattered light image. If this parameter is set to a positive value, the task uses the user-defined ring-shaped region for the background evaluation. Otherwise, a default value (currently set to 350 unbinned pixels) is used for the outer radius of this ring-shaped region.

7 Output Files

1. The OM image with the central scattered light feature removed. If the name of the output file is not specified (the parameter *outset* omitted) then the output file will be given the same name as that of the input file with an extra symbol "S" at the beginning of the name.

8 Algorithm

The intensity of the scattered light feature scales linearly with sky background which varies from image to image, so that the calibrated image has to be scaled and adjusted with respect to the background level of the input image in order to properly remove the central scattered light feature.

The background on the OM images depends on many factors, such as exposures time, spacecraft pointing direction, positions of the sun and the moon, etc. Therefore, one cannot simply use the exposure time of a given OM image for scaling the calibrated image.

The scaling factor can either be determined automatically by comparing the background levels of the same regions of the input and calibrated images or, alternatively, by setting the parameter *scalingfactor* to the desired value in order to force the task using a specific scaling factor.

Currently there are three available algorithms within the task for calculating the scaling factor (the algorithm is chosen by specifying the parameter mode=1,2 or 3, with the default value mode=1).

8.1 Using the peripheral background for computing the scaling factor (mode=1)

The first method of scaling the calibrated scattered light feature is based upon the assumption that the number of counts corresponding to this feature scales linearly with the background level of the OM image.




Figure 3: The ring-shaped region used for finding the background levels of the input image (left) and the calibration image (right) in the case of the default algorithm (mode=1) for calculation of the scaling factor of the calibrated image.

The background is calculated for the same ring-shaped region of both the input (B_1) and calibration (B_2) images (Fig.3). The scaling factor applied to the calibrated image in this case will be

$$S = \frac{B_1}{B_2}$$

and the output image is obtained by subtracting the scaled calibrated image from the input image and restoring the constant background level of the input image:

$$I_{\text{output}} = I_{\text{input}} - I_{\text{calibrated}} * S + B_1.$$

Systematic error is reduced in the background calculation by masking sources in the data image. These are identified by an "Emboss-filtering" technique which compares modified versions of the image, shifted by a few pixels in the horizontal and vertical directions.

A histogram of the remaining pixels is computed. The background value is measured from only the most-populated 10% of pixel values. This reduces bias in the measurement from residual structure such as irregular scattered light.

Thus, B_1 is then obtained as the weighted average of the values of these most populated pixels:

$$B_1 = \frac{\sum_{p_c > 0.9p_{c_{\max}}} p_c \cdot c}{\sum_{p_c > 0.9p_{c_{\max}}} p_c},$$

where c is the number of counts (histogram slot); p_c is the number of pixels having this number of counts; and $p_{c^{\max}}$ is the maximal histogram value corresponding to the most populated count number c^{\max} . The value of B_1 is usually close to c^{\max} .

8.2 Computing the scaling factor with mode=2 and mode=3

The second and third methods of calculating the scaling factor (mode=2 and mode=3) are auxiliary and might be used in some difficult cases when the input image is contaminated by a multitude of other scattered light features (like, "huge deformed donuts", smoke rings, modulo-8 pattern around bright sources, etc.).

These algorithms use two annular regions (instead of a single region, as in the case of the mode 1): the larger one is the same as in the case of the mode-1 algorithm and is used for finding the background levels of the input (B_1) and the calibrated (B_2) images.




Figure 4: Two ring-shaped regions for finding the background of the input image (the larger ring covering the peripheral parts of the image) and for computing the counts of the central scattered light feature (the smaller ring in the centre enclosing the scattered light feature). These are used for two auxiliary algorithms (mode=2 and mode=3) of calculating the calibration scaling factor.

The smaller region (see Fig.4) corresponds to the known sizes of the "donut" of the central scattered light

feature. The count numbers within this region (C_1 for the input image and C_2 for the calibrated image) are found by building histograms of the pixel values, as described in Sec.8.1.

Then, in the case of the mode-2 algorithm, the calibration scaling factor is computed as

$$S = \frac{C_1 - B_1}{C_2 - B_2},$$

and the output image is obtained by subtraction of the scaled and background-free calibration image:

$$I_{\text{output}} = I_{\text{input}} - S \cdot (I_{\text{calibrated}} - B_2).$$

In the case of mode=3 the latter subtraction is made for the scaling factor varied (in a loop) with small steps (of 0.02) from the values 0.2 to 2.8. The optimal scaling factor (S_{opt}) is then assumed to correspond to the minimum of the absolute value of the difference between the background B_1 and the number of counts within the smaller annulus. The final output image will then be:

$$I_{\text{output}} = I_{\text{input}} - S_{\text{opt}} \cdot (I_{\text{calibrated}} - B_2).$$

8.3 The sequence of operations of the task omscattered

Read parameters

Read the input image

Read the calibration image

If the input image is binned than apply the same binning factor to the calibrated image (the calibrated image is supposed to



be a full-frame high-resolution image)

Check that the filters for each file are identical- if not issue a warning.

Prepare the output image by crating an empty array having the same sizes as the input image and copy the header parameters from the input image to the output image

Remove point sources from the input image (by masking them)

If mode=1 (the main algorithm) then

Compute the background B1 inside of the ring-shaped region of the input image

Compute the background B2 inside of the same region of the calibrated image

Compute the scaling factor S as S=B1/B2

Subtract the scaled calibrated image from the input image:

OutputImage = InputImage - S * CalibratedImage + B1

If mode=2 then

Compute the background B1 inside of the peripheral ring-shaped region of the input image $\[\]$

Compute the count level C1 inside of the ring-shaped region corresponding to the central scattered light feature of the input image

Compute the background B2 of the peripheral region of the calibrated image

Compute the count level C2 inside of the ring-shaped region corresponding to the central scattered light feature of the calibrated image

Compute the scaling factor S as S=(C1-B1)/(C2-B2)

Subtract the scaled calibrated image from the input image:

OutputImage = InputImage - S * (CalibratedImage - B2)

If mode=3 then

Compute the background B2 of the peripheral region of the calibrated image

In a loop changing the scaling factor from S=0.2 to 2.8 with spep 0.02:

Subtract the scaled calibrated image from the input image:

OutputImage = InputImage - S * (CalibratedImage - B2)

Compute the background B1 inside of the peripheral ring-shaped region of the output image $\$



Compute the count level C1 inside of the ring-shaped region corresponding to the central scattered light feature of the output image

Compute the difference between the count levels of these two values:

D = abs(C1 - B1)

Chose the optimal value of the scaling factor $S_{\mathtt{opt}}$ correponding to the minimum of D from the above loop

Subtract the scaled calibrated image from the input image using the scaling factor S_opt:

OutputImage = InputImage - S_opt*(CalibratedImage - B2)

Write output image




Figure 5: The same example of the XMM OM image as in Fig.1 after applying the scattered light removal algorithm (Mode=1, Obs. ID 0112250301, exposure 006, filter V).

The main algorithm (mode=1) is used as the default option for the task. An example of the output image obtained by applying the algorithm with mode=1 to the input image from Fig.1 is shown in Fig.5.

9 Comments

• A new attribute SCFACTOR is introduced into the attribute table of the output file. The value of this attribute corresponds to the automatically computed scaling factor for scaling the calibrated image before its subtraction from the input image. This value can be used for adjusting the scaling factor and obtaining better results by setting the parameter scalingfactor to a value defined by the discretion of the user.

9.1 Future developments

- It is likely that the calculation of the scaling factor for adjusting the image with the calibrated scatted light feature to the input image would need further improvements. In some cases the scaling factor might be slightly overestimated (as it is seen, e.g., in Fig.5).
- Currently the calibration files with the central scattered light feature are not included into the calibration (CAL) system of SAS, but the proper way of using these files would be through the standard CAL routines.
